LIST OF OFFENCES & FINES 2010-2011

OFFENCE	PENALTY
Failure to send representative to the Annual General Meeting or an EGM.	€100* Fine
Failure to send a representative to a Meeting called by the League.	€25* Fine
Failure to complete match card completely e.g. omitting player's names, ID numbers, or manager's signature.	€10* Fine
Failure of home side to submit match card within 7 days, if no referee present.	€10* Fine
Failure to text/email match results to the League by 6pm Sunday night.	€10* Fine
Failure to present ID cards when requested.	€20* Fine. Point's deduction, or forfeit of cup match, may also apply.
Yellow Cards.	Any player who accumulates 3 or more yellow cards will be reported to the Disciplinary Committee. Suspension and/or fine may apply.
Red Cards.	€20* Fine and Automatic one match suspension apply. Suspension to be served in same competition. If team knocked out of Cup, then suspension to be served in League. Further suspension may also apply depending on nature of offence as determined by Disciplinary Committee. In all cases the player, team manager, and club secretary will be invited to appear before hearing. Parent/guardian may accompany player.
Failure to meet pitch requirements	€25* Fine. Any referee fees incurred must be paid by the offending home team. Home advantage will be removed until pitch requirements are met.
The playing of overage, unregistered, or inappropriately registered players.	€20* Fine and automatic 3 Points deduction apply. Match forfeited in Cup competition. If league match, then fixture may need to be replayed if determined by Disciplinary Committee
Failure to control sideline, respect Referees, Coaches, players and/or League Officials.	€25* Fine. In all such cases the matter will be referred to the Disciplinary Committee and further points deduction and/or fine may apply (max €100).
Failure to answer to a protest (within 7 days), or to attend a hearing, when requested to by the League.	Club's fixtures will be delayed until response is received, or until hearing rescheduled.
Failure to fulfill fixture	Clubs giving a walkover are liable for full referee's fees and expenses. Additional fine and/or points deduction may apply as determined by Disciplinary Committee
Two consecutive or three walkovers in a season.	Team may be expelled from the League and additional fine may apply as determined by Disciplinary Committee
Abandonment of a match.	As determined by Disciplinary Committee based on Referee's Report.
Disbanding or Withdrawal of team during a season.	As determined by Disciplinary Committee. Players registered with the League remain property of the League

*Fines listed are for first time offences. Repeat or persistent offending may incur increased fines as determined by Disciplinary Committee. All fines must be paid within seven days of notification. Non-payment may result in delay to Club's fixtures. In addition to the above items, the League may at its discretion, asks the Disciplinary Committee to investigate any situation that it deems necessary and appropriate to investigate. Reasonable and relevant penalties may be issued to clubs found in breach of rules, protocols & procedures, or codes of practice.
